Honorable Members, I wish you well during the long break. I trust you all will have a worderful and fruitful break together with your families and electorates, including a break for self and institutional evaluation and come back in February re-energized, reinvigorated and with a stronger sense of purpose to deliver for the people of Garissa.

I take immense pride and satisfaction, that we have made significant progress as an institution I wish to highlight some of the achievements:

New Assembly Building

We have recently also made the bold move of clearing the food kiosks that were at the main entrance and along the perimeter wall of the County Assembly. This Assembly now has a new look, a better ambience and is more secure.

Better Visibility

Hon. Members, in line with the provisions of the Constitution of Kenya 2010 on transparency, accountability and access to information, we have made a significant milestone in the way we engage the public.

We are among the handful few Assemblies that broadcast their proceedings via a live-stream. The broadcast of our proceedings has without doubt impacted audiences' perceptions and attitudes on overall roles of the Assembly. The communication team also shares updates and highlights of the proceedings to inform the members of the public about how well the Honorable Members are exercising their representative mandate.

Enhanced Legislation

Hon. Members, it is encouraging to note that this Third Assembly has so far processed and passed considerable number of legislations that provide legal framework for the operationalization and enhancement of service delivery in Garissa County.

Notably, we have approved the creation of 3 new Municipalities - Dadaab, Modogashe and Bura Municipalities. I am aware that the elevation of Balambala to a Municipality status is awaiting the completion of public participation by the concerned committee.

Honorable Members, the creation of municipalities is one thing, operationalizing them is another. I call on the House to ensure that the newly created municipalities are effectively operationalized and the transfer of municipal functions is executed in due course.

Most of these legislations have been enacted and operationalized. We have also debated and passed 10 substantive motions, considered 69 statement requests, processed over 45 committee reports and one (1) public petition that address the challenges of the people of Garissa and improve their socio-economic well-being. Congratulation MCA.

This is attributed to capacity strengthening of Hon. Members and Secretariat who have exhibited high level of professionalism as well as enhanced civic educatric for Table SARD EDITOR P. O. BOX 57,70100 GARISSA information by members of the public.

However, we have had countless number of times the House adjourning owing to quorum hitches - an area we need to improve on when we come back from the long recess if we are to dispense more crucial matters.

Honorable Members, the issue of strict adherence to the dress codes should be an area we ought to improve on when we come back.

Improved Oversight

Honorable Members, courtesy of our new Standing Orders No. 48, we have invited 4 CECMs to appear before the full House and Committees to get clarification and answer queries emanating from the statement requests of the Members.

However, the Assembly will no longer condone dilly-dallies on the part of the County Executive for not honoring the invites when we resume in February 2025.

Honorable Members, I need to bring to your attention that County Allocation of Revenue Act 2024 has reduced the recurrent budget ceilings for County Assemblies. Our Assembly has lost about Ksh. 275 million. The County Assemblies Forum (CAF) is going to court to halt the implementation of the CARA 2024.

Going forward, we ask for your patience as the budgetary cuts will drastically affect the operations of the Assembly and I call on all to consider the prudent utilization of the scarce resources.

Moving forward, we remain committed to achieving our vision of being a model, independent and people responsive County Assembly in Kenya.

Hon. Members, as we break today, I wish to encourage you to take time off to refresh and reenergize as we look forward to even greater milestones next year, 2025. Insha'Allah I also encourage you to take time to be with your constituents so that you can build a better understanding of their feeling and challenges that we can seek to address when we resume next year.

Finally, I wish to take this early opportunity to wish all Hon. Members and staff a Happy New Year, 2025 and enjoyable holidays and festive season.

Hon. Khadija Idris (Chair Lands, Physical Planning and Urban Development): Mr. speaker, I hope ever member has a copy of the report. The report is voluminous, I want to guide members the pages that I will be reading. Thank you.

On Acknowledgement Mr. Speaker Sir, the production of this report is a testament to the dedication and commitment of the Members of the Committee, who, despite their demanding schedules, devoted their time to attend meetings and deliberate on this report. The Committee extends its gratitude to the offices of the Speaker and the Clerk of the County Assembly for their invaluable planning, coordination, and facilitation of this undertaking. We also

recognize and appreciate the efforts of the Secretariat, which provided essential technical and legal support during the review and approval process of this plantice of the Hansard Editor

NOW, THEREFORE, pursuant to Section 111(6) and Section 14(3) of the County

Governments Act, 2012, and Garissa County Assembly Standing Order, the Committee hereby submits to this House the report on the consideration of the Garissa Municipality Integrated Development Plan (IDeP) for approval by this House.

Mr. Speaker Sir, on page 13. Considering these legal requirements, it is evident that rapid urbanization is placing significant strain on the resources and infrastructure of our municipalities and towns. As urban populations grow, there is an urgent need to plan for effective management of these increases. Approval of the Integrated Development Plans (IDeP) will serve as a vital tool to address the challenges anticipated within Garissa municipality.

This planning approach empowers Town and Municipality Management Board to manage and mitigate emerging challenges effectively. With such plan in place, Garissa municipality can guarantee an improved quality of life for the residents. However, given the dynamic nature of urban spaces and population movement, planning must remain an ongoing process. On Effective Strategic Urban Planning Process Mr. Speaker, it is necessary that this House is informed of what makes or entails a comprehensive and effective Integrated Development Planning process. In this examination, the Committee was guided by the County Spatial Planning Guideline, 2018 developed by the Ministry of Lands and Physical Planning in collaboration with the Council of Governors (CoG). It was noted that, for the success or failure of any Integrated Strategic Urban Development Planning process, there are many factors combined to add to the success of these plans. For example, the plan focusses on the future and aim at predicting how each municipality's environment will look and function within a specified period of time. For the case of IDeP, the period for Garissa municipality spans as follows: -

On Committee Observations Mr. Speaker, on page 19. In light of the considerations made by the Committee on the Integrated Development Plan for Garissa Municipality, the Committee observed **THAT**:

- 1. The preparation process of the integrated Development Plant (DeP) was participatory and adhered to urban planning guidelines.

- 2. The Integrated Development Plan (IDeP) complies with all relevant constitutional and statutory requirements.
- 3. The plan effectively addresses the specific developmental and regulatory needs of Garissa Municipality.
- 4. The Integrated Development Plan (IDeP) identifies necessary interventions and promotes collaboration with stakeholders to ensure effective implementation.
- 5. The Integrated Development Plan for the municipality can be reviewed and amended annually, if necessary, as provided under Section 42 of the Urban Areas and Cities Act, 2011 (amended in 2019).
- 6. The Committee observed that due to inadequate planning, all the Lagas (streams) have been encroached upon.

On Committee Recommendations Mr. Speaker, From the submissions made by the participants during the exercise, interactions with experts, the departmental officers and the committee deliberations, the Committee therefore, unanimously recommends that this House approves Garissa Municipality integrated Development plan 2023-2028 with the following recommendations: THAT:

- 1. This County Assembly APPROVES Garissa Municipality integrated Development Plan pursuant to Section 111 (6) and 14 (3) of the County Government Act, 2012 and Section 38 and 39 of the Urban Areas and Cities Act, 2011.
- 2. THAT the Municipality be granted autonomy to implement the transferred functions in accordance with its respective Charter of Service as outlined in the Third Schedule of the Urban Areas and Cities Act 2011 (as amended in 2019).
- 3. The Municipality Board to develop By-laws that shall govern and regulate activities, management and operations of this municipality in line with functions and powers bestowed upon them in section 56 of the Urban Areas and Cities Act 2011) and present to the County Assembly for approval.
- 4. The municipality shall submit quarterly reports on the implementation of the Integrated Development Plan 2023-2028 to the Assembly without fail.

5. The municipality shall ensure that all buildings within its jurisdiction are accessible and office of the hansako editor inclusive for individuals with disabilities.

- 6. THAT When naming roads within the Municipality, the Municipality shall prioritize the recognition of local heroes and heroines.
- 7. Establish mechanisms for continuous Monitoring and evaluation to track progress and make necessary adjustments of Integrated Development Plan.

On Conclusion, Mr. Speaker, The Committee is satisfied that the IDeP for Garissa Municipality adheres to all legal and procedural requirements and offers a comprehensive framework for sustainable urban development. Its approval will enhance the municipality's capacity to address urban challenges and improve the quality of life for its resident.

We appreciate that once we have adopted this report, we should emphasize on the implementation of this recommendation we have done as members of the committee and we should follow up so that Garissa will get back its lost glory, Inshallah. Hon. Mohamed Farah (Majority Leader): Thank you, Honourable Speaker. Honourable Speaker, first I want to thank the Committee for Land. Honourable Speaker, I participated in

the public participation that was done by this committee. I was part and parcel of this IANSARD EDITOR progress that came through the Committee for Land. Honourable Speaker. My Colleague Honourable Timira said that a plan for Garissa was done way back in 1982, meaning that it was very necessary for the County of Garissa to undertake this process. Honourable Speaker, IDEP (Integrated Development Plan), is a strategic tool used for development. Mr. Speaker, Garissa is growing. Population is increasing day in, day out. There are a number of villages being formed or created. There are a lot of people who need water services close to their houses. You know, electricity poles are supposed to reach homesteads and this can only be done making sure that important plans are passed in the Assembly and make sure that this strategic tool must be used to make sure that we reach to the population that has not been reached since 1982. Honourable Speaker, it is only within the Garissa town that was planned in 1982, meaning various strategic points that people have now allocated lands far west of, you know, Waberi, including Galbet Ward, Iftin and all other areas, including township itself, has not been captured very well since 1982. Therefore, Mr. Speaker, this plan is very important for Garissa and we believe strongly that the commitment for this Land Committee is real. It has to keep the ball rolling, making sure that the executive arm works and make sure that the people of Garissa are reached in their far end so that water issues are resolved, making sure those plans affect and become effective programmes for the people who are living. Mr. Speaker, if you see when floods come in, there is havoc throughout. People of Garissa cannot even make sure that they attend to their daily duties because of those floods and all this is happening because of poor planning and with the effect of this plan, Honourable Speaker, it is my hope that all these problems will be resolved so that we see Garissa goes again and does a plan that will be effective in 2024, in the coming 10 years, so that we see people should not be settling haphazardly. There should be a plan to allocate where schools are supposed to be. We see where hospitals are to be allocated. Hospitals, other social amenities, Mr. Speaker and in that context, Honourable Speaker, I support the report of the committee and request the members to equally support this important report. Thank you.

Hon. Speaker: Thank you, Honourable Majority Leader. The Honourable Minority Whip, Honourable Fatuma Shide.

Hon. Fatuma Shide: Thank you, Mr. Speaker, Mr. Speaker, I join my colleagues to congratulate my super chair and the members, which I'm one of themFFICE OF THE HANSARD EDITOR Mr. Speaker, the plan has just been brought on timely. Mr. Speaker, as the Majority Leader said this town has been planned. Some rest but in 1982 by one of the councilors called Mzee Sahel Dumiye. They named him Sahel Dumiye but by that time, people were feeling it was bad because he was demolishing houses. But later we came to find out that Mzee has really done a lot of good work. I believe with this committee and the CEO municipality, same will happen so that we can get access roads, feeder roads, and even the waterways to be unblocked. Because currently, you can see, if you go to where I come from Waberi, where I live, some people have even constructed on the laga. That laga is blocked and when it rains, that's how we are getting the floods. You see the markets; People were sitting like orahey right now when we removed it. It's because of the poor planning. The government houses had to be demolished so that we get a market for the community. Mr. Speaker, I also like the way the committee recommendation, one of the parts that says the quarterly report should be brought to this house, which means there will be a working relation between the municipality, the CEO municipality, and the members in this house like the lands committee. It's a way forward and a very important part of the report. Mr. Speaker, I also saw there was a lot of good things like if right now fire breaks in some parts of even the town that was planned like Garissa, just behind to build this Sug-mugdi; the houses are so congested that if one house burns, there's nowhere to access to help that house. If that community gets somebody died in one of the houses here in Garissa, just here across the assembly, there's nowhere even to pass the ambulance so that you can rescue that person. So, Mr. Speaker, I support the motion and I am one of the committee members and I will really help. Thank you.

Hon. Speaker: Thank you. The Honourable Mohamed Sheikh.

Hon. Mohamed Sheikh: Thank you, Mr. Speaker. From the onset, I start to appreciate the good work of the committee headed by the able chair, Honourable Khadija Idris. Honourable Khadija Idris is a daughter born in Labasigale; That is where she was born and brought up before she schooled in Garissa. That is her area. So, I appreciate the good work she's doing and together with the committee Clerk.

I was not talking about where she has voted in the last election, but I talked about where she was born and she's here. She can even attest to that and even during the voting, she voted in Labasigale Primary School. I think you can even avail her details from the IEBC records. Going forward, Mr. Speaker, as a member of this committee, we had engagement with the public during the public participation and one thing that I like about the public participation is it involves almost all the stakeholders that are required as per the guidelines and these were people who are professionals and who are very keen. They gave out a very... In fact, they interacted with the document and they gave out their views. All their views, most of the views are in the report and some of the areas that I was very keen about is people with different abilities. Some people call it disability, but I call it people with different abilities. Some of the challenges that they faced in Garissa and this municipality is accessing the public offices and private also hotels because accessing hotels and conferences is becoming a challenge. If it's not on the ground floor, going to the first floor is becoming a challenge because it's not disability friendly. Some of the concerns that they have raised in our plans, next time by the time we are approving any development or any construction of those high-rise buildings, it must be there to those guidelines. The other thing is the essence why we have IDEP is mainly for planning purposes because if you have a good plan, you can allocate your budget very well. You can use or utilize your resources very well.

So, for planning and budgeting purpose and also investment, when you want to develop a certain area, you must have a good plan to undertake whatever resource you want to allocate to that place and also the investment that you want to invest in that area. And also, if there are partners who are ready to support, if the plans are in place and approved by the house, that

Hon. Mohamed Sheikh: Thank you, honourable speaker, all the members have this report. The Report on the Proposed Garissa Municipality Spatial Plan. I request members to go to page 3 of the report; on Executive Summary, the preparation of this Plan is guided by the County Government's decision to develop a plan for Garissa municipality, which has lacked one since independence. The primary objective is to establish a framework to guide the Municipality's development and serve as a foundation for creating the Garissa Municipality Land Use Plan. This has been achieved by rationally and appropriately allocating land for various uses within the designated area. The guiding principles in the development of this Plan include promoting optimal, efficient, and economic land use, as outlined in the National Land Policy; encouraging walkability, health, harmony, safety, and efficiency; fostering

inclusive and coordinated governance systems; and structuring urban development to support environmental sustainability.

Lastly, the plan is envisioned to be fully implemented in order to achieve its objectives and align with Kenya's Vision 2030. This will be accomplished by adhering to the zoning standards and regulations provided, as well as complying with any other laws governing the development of urban areas and cities in Kenya.

- e) investigate and inquire into all matters relating to the assigned department as they may deem necessary, and as may be referred to them by the County Assembly.
- f) vet and report on all appointments where the Constitution or any law requires the County Assembly to approve except under Standing Order 184 (Committee on Appointments);
- g) make reports and recommendations to the County Assembly as often as possible including recommendation of proposed legislation.

Mr. Speaker Sir, on page 13; In support of the spatial plan, members of the public made the following proposals;

On the importance of having a spatial plan for the Municipality

Members of the public informed the committee that the plan has been in place since 1982 and is on track, as planning precedes development. Regarding topography, the department should prioritize matters related to plot assignments. employed when assigning plots. Members of the public proposed that there was need to prioritize development in underserved areas to ensure equitable access to essential traditional education, and utilities.

On infrastructure Improvements

Members of the public suggested the need to upgrade road networks, drainage systems, and energy access infrastructure, emphasizing reliability and efficiency. Participants also recommended inclusion of a places of worship, feeder roads, water and power lines, as well as drainage systems in the plan. Additionally, they highlighted the importance of maintaining roads, such as bush clearing, and proposed the inclusion of streetlights in the plan.

On Gender and disability Inclusive Planning

participants proposed that Roads should be accessible throughout the year. During road construction, consideration should be given to people with disabilities, ensuring the roads are disability-friendly. Buildings should also be designed to accommodate people with disabilities. Measures should be implemented to address the issue of double-parking. Participants urged the Municipality to design public spaces, streets, and facilities that prioritize safety, accessibility, and usability for women, children, and people with disabilities.

Public Perspective on Affordable Housing Development

The public emphasized the critical role of the municipality in addressing the rising demand for affordable housing. They proposed that the municipality should prioritize land allocation as a foundational step in the development of affordable housing projects. By identifying and designating suitable parcels of land within the municipality, the local government can significantly reduce costs associated with housing development, thereby making homes more accessible to low- and middle-income households.

On environmental Conservation

The stakeholders emphasized the importance of preserving and expanding green spaces, and parks within the municipality as a vital step toward environmental conservation and sustainable urban development. By protecting these natural areas, the municipality can enhance biodiversity, providing habitats for various plant and animal species, while also creating a healthier environment for residents. These efforts collectively contribute to improving the quality of life, fostering community well-being, and promoting environmental resilience in the face of rapid urbanization and climate change.

On Public Participation

Stakeholders requested the municipality to organize public forum. Surveys, and workshops to gather community feedback throughout the planning and implemental properties. Spatial plan.

On climate Resilience

The participant informed the Committee that the municipality to identify and protect high risk areas from flooding or erosion, and invest in climate-resilient infrastructure such as massive tree planting.

On public Transport in the Municipality

The stakeholders proposed the Municipality to develop efficient and affordable public transport systems, including bicycle lanes and pedestrian pathways.

Overall, View of the Public

The public were generally receptive and in full support of the Municipality spatial plan. Members of the public urged the municipality to integrate these recommendations into the spatial plan to ensure it reflects the community's priorities and promotes sustainable, inclusive development. It was in their general view that the creation of the municipality spatial plan would be beneficial to the residents of the Municipality in terms of service delivery and the overall management of the municipality.

On Committee Observations; The committee made the following observation in regards to the Garissa municipality spatial plan:

- a) The plan is intended to guide the Municipality's development for the next 10 years.
- b) The plan is GIS (Geographic Information System) based plan
- c) The plan covers all critical areas that would spur both economic and social development in the Municipality.
- d) The plan requires a wide stakeholder consultation, capacity building, sensitization and awareness building to internalize the plan as legal document with its benefit, output, impacts and constraints for future development of the Municipality.
- e) The municipality need to strictly adhere to the plan proposals on environmental conservation by creating awareness on wildlife corridors to enhance tourism activities in the Municipality.

On Committee Recommendations; Mr. Speaker Sir, From the submissions made by the participants during the exercise, interactions with experts, the departmental officers and committee deliberations, the Committee therefore, unanimously recommendations:

- 1. That, the Municipality to ensure that the spatial plan supports environment sustainable growth by incorporating green spaces, renewable energy solutions, and efficient waste management systems.
- 2. That, the Municipality shall focus on improving road networks by upgrading main and access roads into bitumen standards, drainage systems, and energy access.
- 3. That, the Municipality to protect historical sites, wildlife, forests, and water bodies to preserve the municipality's heritage and biodiversity.
- 4. That, the Municipality shall involve residents in the decision-making process through consultations, workshops, and feedback sessions to ensure that the plan implementation reflects their needs.
- 5. That, the Municipality to Plan for climate change adaptation by zoning areas prone to flooding or other natural disasters and integrating disaster response infrastructure.
- 6. That, the Municipality should focus on developing efficient public transportation systems while incorporating infrastructure for pedestrians and cyclists to alleviate traffic congestion.
- 7. That, the Municipality to Identify and designate areas for industrial establishment and commercial markets to stimulate investments, drive economic growth, and generate employment opportunities.
- 8. That, the Municipality to establish benchmarks and timelines for implementing the spatial plan, with regular reviews to adapt to emerging challenges and opportunities.
- 9. That, any sector/development partner that want to partner with the Municipality must adhere to the laid down policies and practices of the Municipality.

of committees, on areas of discipline, what they do in the Assembly, those who do legislation, those who are administrative, also to go and do training on administration, so that they have a refresher course. I am sure Kenya School of Government is not like any other school of government. They go and reward the staff, those who go and attend important trainings, like the senior management course and also Senior Leadership Development Programme courses, which are tailored courses. Madam Speaker, the Secretariat, and I said earlier that we need to also see what benefit they should reserve in terms of their families and their medical cover. Upgrading of staff and elevating them to higher positions, which they deserve, most of them. I have stayed with them here for too long and I know most of the members of the staff, particularly the Secretariat, have reached a stage where they are supposed to be upgraded.

I am sure if the Speaker would have been here, this recommendation must have been recorded very well, so that it reflects very well in our day-to-day operation in the Assembly. Madam Speaker, I kindly share this with the Speaker and also the administration wing. Our deputy clerks are also seated here.

Let us improve the Secretariat, their life stage in this Assembly. Now we are closing the Assembly. We are going through a long process.

We have also a member for Nanigi, Honourable Abdullahi, also representing us on Kenya-Kwanza. The two other public members, also representing the entire Assembly including our Speaker, the Secretary, who is our Clerk, to make sure that medical cover for both the staff and members of the County Assembly is improved. There is a new scheme that has already been enrolled throughout our country and that is SHA (Social Health Authority).

We need to come to terms, and we must get advice from people we know, on how this SHA is behaving because most of the Kenyans are now arguing that it is not good, as others are putting it. Madam Speaker, medical cover is crucial, it is important. We want to see this medical cover covering a wide range, both our staff and our members. So that by the time we enter into agreement with them, we see the benefits it carries, alongside what is required within our stack, as members who are elected and those who are specially elected. Otherwise, Madam Speaker, that is a good reflection, and it is my belief and hope that next time when we come back, we shall come back energetic, and keep the ball rolling, God willing. I say goodbye to all of you, since we shall be leaving from tomorrow, back to our homes. Thank you, Madam Speaker. Thank you.

As we break for this long recess, the issue of the medical cover is being undertaken. We have advertised and I'm sure in a couple of days it will be up and running. I know of, I'm sure, I cannot be able to talk about the procurement issues here but something that is of importance to all of us, medical cover and it is being addressed, advertisement has been done, and the board is, we have just discussed in our last meeting, and that the procurement process is at the last stage and hopefully it will be up and running soon. Because the other one has expired around 14th of December 2024. Other issues are some administrative matters. Which I'm sure I'll take note of that, and address to the board. We have a board meeting, a full board meeting this weekend, coming Saturday in Nairobi. Therefore, these issues are on our list.

However, your mention of emphasizes the importance, therefore they will be addressed. Thank you. I just wanted to communicate that as we break, the committees will be able to function. The committee will work, but only basis. So, in consultation with the speaker and the clerk, committees that have got urgent work. Now I know already that the budget has got something on the table. Therefore, in close coordination, we can be able to work together to ensure that much as we go for our well-deserved holidays or breaks, but nevertheless, we still need to have the committees that have got urgent matters to address, can still work, but in close coordination with the clerk and the office of the speaker, so that we can be able to allocate you the requisite staff and resources. Thank you. Next. The Honourable Majority Leader.

Hon. Mohamed Abdi Farah (Majority Leader): Thank you, Mr. Speaker. We have forgotten that today is an adjournment day, where we are supposed to close the assembly until 11 February 2025. Therefore, I request your office, this motion remains relevant for us,
